## Dear Farmers Institute Representative:

The Honourable Lana Popham, Minister of Agriculture, is inviting all Farmers' Institutes in British Columbia to participate in a full day event on **November 29, 2019** at the **Four Points by Sheraton Vancouver Airport**, 8368 Alexandra Rd, Richmond. The hotel is near the Vancouver International Airport.

Each Farmers' Institute in the province is welcome to send one representative. Travel, accommodation and meal costs for that representative will be reimbursed by the Ministry of Agriculture.

The event is intended to provide an opportunity for Farmers' Institutes to interact directly with each other and discuss areas of common interests, challenges and opportunities. We'll start the day off at 8:30 AM with arrival/sign-in and then move into the formal part of the day at 9:00 AM and wrap-up by 3:00 PM. The final agenda will be forthcoming but is expected to include the following topics:

- Agricultural Land Reserve (ALR) and Agricultural Land Commission (ALC)
- Ministry of Agriculture Programming updates
- Discussion session with the Honourable Lana Popham, Minister of Agriculture

## Registration requires two steps from you:
